

1. NAME OF THE SOCIETY : TNR EDUCATIONAL SOCIETY

2. LOCATION OF THE OFFICE : Plot No.23, GLR Enclave, Pipe Line Road, Opp. NCL Godavari Apartments, Pet Basheerabad, Suchitra, Qutubullapur, IDA Jeedimetla, Rangareddy-500 055, Telangana.

3. (i) MEMBERSHIP:

- Any person aged above 18 years and who is interested in the objects of the Society may make an application for admission as a member.
- The said person may be admitted at the discretion of the Executive Committee. The decision of the Executive Committee shall be final.
- The fee shall be refunded if the application for membership is rejected by the Executive Committee.
- Whenever a member acts against the interest of the Society, he shall be removed from the Society with a two-third majority and shall be given an opportunity of being heard.

(ii) ADMISSION FEE: The application shall be accompanied by a fee of Rs. 1000/-

4. FUNCTIONS:

- To pass the budget for the ensuing year and approve the income and expenditure statement of previous year.
- To approve the reports of the activities of the Society.
- To elect the Executive Committee etc.
- To appoint Auditor.

5.

- Executive Committee: Shall consist of Seven (7) Members and out of them, the following office bearers shall be elected by the E. C. Viz. President, Vice-President, General Secretary, Joint Secretary and Treasurer and the remaining persons are the Executive Committee members.
- The members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see that the signatures of the outgoing Governing Body tally with the annual list as filed with the Registrar of Societies before 15 days of the succeeding month in which elections were held.

(iii) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

1. **PRESIDENT :**

He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in the case of tie in decision making. He can supervise all the branches of the Society.

2. **VICE-PRESIDENT :**

He shall assist the president in discharge his functions and duties. In the absence of the President he will perform the duty of the President as entrusted by the President.

3. **GENERAL SECRETARY:**

He is the Chief Executive Officer of the Society and Custodian of all records relating to the Society and corresponds with various departments on behalf of the Society. He has to take on record all minutes of the Society, would convene both the Executive Committee and General Body of the Society with the permission of the President. He guides the Treasurer in preparing the budget and expenditure statement to place before the General body for its approval.

4. **JOINT SECRETARY :**

He has to do the work as entrusted by the Executive Committee He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can discharge the duties of the Secretary.

5. **TREASURER :**

He is responsible for all the financial transaction and funds of the Society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the Society with the guidance of the Secretary or President.

6. **OFFICE BEARERS :**

They are responsible persons to attend to such activities of the society which the Executive Committee entrusts to them.

7. **QUORUM :**

Half of the total members for General Body meeting and 1/4 for Executive Committee meeting.

8. **AMENDMENTS:**

The society in an extraordinary general meeting called for the purpose with prior circulation of proper resolution and with the two-thirds majority of the members present, may amend, alter or add its memorandum of the society.

9. **WINDING UP:**

In case the Society has to be wound up the property and funds of the Society that remained after discharging the liabilities if any shall be transferred to any other institution with similar aims and objects and which is approved and registered as charitable institution under the provisions of the Income Tax Act, 1961.

**10. FUNDS:**

The funds of the Society may be raised through any loans taken from the Banks or other Financial institutions. The funds raised and any surplus arising from the activities of the society shall be invested in the Government Securities permitted for the society or to remain in the Bank in F.D. or S.B. accounts in accordance with the provisions of the I.T. Act 1961, no part of the funds shall be invested in shares or advance for loan to others or transferred directly or indirectly to any of the members of the society.

**11. General Body:**

Annual General body will meet once in a year i.e. in the month of June.

**12. BANK ACCOUNT:**

The Executive Committee of the society may from time to time open and maintain in the name of the society, bank account or accounts with scheduled banks and same shall be operated either by President or **General Secretary or Treasurer** of the society. The account(s) may also be operated by such executive members or officers or employees as may be nominated by the Executive Committee from time to time.

**13. ACCOUNTS AND AUDIT:**

- (i) The society shall maintain regular and proper accounts of all receipts, payments, properties, assets and liabilities. Such accounts shall be kept at the office of the Society in the direct charge of the Treasurer of the society.
- (ii) The financial year shall end on 31<sup>st</sup> March every year. The accounts shall be audited by a Chartered Accountant to be appointed by the Executive Committee of the society. The audited accounts and the report of the auditors shall be placed before the General Body meeting of the society, in its meeting to be held in **June** each year.

**14. MINUTES OF THE MEETING:**

The Executive Committee will hold its meetings at least once in every quarter and will maintain the proceedings, in a bound register. Minutes of the meeting are to be confirmed in the next meeting and are to be signed by the chairman of the meeting.



**15. EXTRAORDINARY GENERAL MEETING:**
